- 2. Board will present and ask shareholders to vote on the Line Amendments (emailed and posted online Jan 9<sup>th</sup>) whether the new Bylaws are ratified or not.
  - No vote will be taken unless two thirds of all stock is represented in person or via proxy.

### **Election of Officer(s):**

Term has expired for Eddie Clement and Tony Vervloet. These board seats are open for election. Anyone wanting to run for a board seat can be nominated at this time.

# Other Discussions that add value to the Clipper Ditch Annual Meeting

## **Adjourn Meeting**

The ditch Company's responsibility for delivering water ends at the diversions off the main lateral(s) from this point on it is the responsibility of the owner to maintain that ditch and all appurtenances. It will also be the responsibility of the shareholder to keep the area around and access to the meter and/or the Parshall flume **clear of weeds and willows**.

- a) If a meter is present it will be considered the primary and correct measuring device unless it's determined by the ditch rider to be malfunctioning.
- b) When a flume is being used as the primary measuring device it;
  - 1. must be level front to back and from side to side.
  - 2. must be clean in front with a stilling basin. Water should be "still" to flow into flume.
  - 3. water must not backup in the flume and needs to flow freely from the flume
- c) Clipper Ditch is not responsible for incorrect flows to shareholders if the flume is not level and readable.
- d) Project water from Crawford Reservoir will not be turned to shareholders unless flumes are level and readable.
- e) Valves to all meter runs will not be opened, for any reason, during the winter months and early spring. If for some reason you need to open a meter run please contact the ditch rider or a Board member (970) 414-0106. If after careful review by the board it is determined that the meter was damaged by shareholder negligence the meter will be replaced at shareholders expense.
- f) Each shareholder must have current stock certificates in the correct name and/or business. It is important that if land is being sold that the water certificates correctly reflect the new ownership.
